# REGULAR MEETING MINUTES April 6, 2022

Chair Comnick called the meeting to order at 7:01 p.m., and the pledge of allegiance was recited.

- **B.** MINUTES: Motion made by Kevin Comnick, seconded by Penny Dieryck to approve the March 2, 2022 Regular Meeting minutes and the March 8, 2022 Board of Canvass minutes as written. Motion carried unanimously, 3-0.
- C. TREASURER'S REPORT:

### **OLD BUSINESS**

- A. PLANNING AND ZONING: Comnick stated that there was a complain on Vaux Road. He notified the county.
- B. FIRE RELIEF: Assistant Chief Sandstedt stated that the annual audit in on track.
- C. FIRE DEPARTMENT:
  - a. Assistant Chief Sandstedt stated that they held trainings on the MNFire Deep Dive for cardiac awareness, radio communications/incident command, strategies, and tactics. He stated that they will also be purchasing some uniforms.
  - b. Dieryck asked if they intended on putting burn boxes by the trail head. He stated not at this time.
  - c. The board discussed the replacement of the fire door locks. **Motion** made by Kevin Comnick, seconded by Penny Dieryck to approve the Amendola Builders quote up to \$25,560 to upgrade the door locks on the town hall and upgrade the doors to accessible ones. Motion carried unanimously, 3-0. **Motion** made by Penny Dieryck, seconded by JeffErikson to approve the ESC Systems quote up to 11,633.71 for the installation of cameras at the fire hall and town hall entries and the rec area. Motion carried unanimously, 3-0.

**D. ROADS:** Comnick stated that the roads are in typical condition for spring. There are a couple of culvert concerns which he will be investigating and the asphalt roads will be striped this year. The board discussed Resolution 2022-2 to close the northern entrance to the town hall parking lot. The Road Foreman and Fire Department were not concerned about the closure. **Motion** made by Kevin Comnick, seconded by Penny Dieryck to approve Resolution 2022-2. Motion carried unanimously, 3 – 0.

E. RECYCLE SHED: Treasurer Borndal stated that the grant is still being considered and they should have everything they need.

- F. RECREATION AREA: Dieryck stated that she has been investigating quotes for the new playground and they are about \$150K without the land work and installation. If they were to rubberize the playspace it would be closer to 300-400K. The board discussed funding options. Dieryck will continue to research and plan the project.
- G. CEMETERY: None
- H. PLAWCS: Comnick stated that the lift station 2 was in need of significant repair and that it would cost about 200-250K to repair. The board discussed options for supporting the repairs. Motion made by Kevin Comnick, seconded by Penny Dieryck to utilize up to \$69,000 of ARPA funds to have MSA Engineering purchase four control panels for PLAWCS lift stations 1, 3, 4, and 5 that will be owned by PLAWCS. Motion carried unanimously, 3 0.
- I. BUILDING MAINTENANCE: None
- J. AIS: Comnick stated that there is in person training on 4/30/22 at the town hall for AIS employees.
- K. MISC: None

#### **NEW BUSINESS**

- A. Liquor Licenses: **Motion** made by Penny Dieryck, seconded by Jeff Erikson to approve the SuperOne 3.2% liquor license for 2022. Motion carried unanimously, 3-0. Motion made by Penny Dieryck, seconded by Jeff Erikson to approve the Pike Lake Golf Club's request for support of a county liquor license for 2022. Motion carried unanimously, 3-0.
