REGULAR MEETING MINUTES December 8 2022

<u>ATTENDING</u>: Chair Kevin Comnick, Supervisor Penny Dieryck, Supervisor Jeff Erikson, Clerk Amber Madoll, Treasurer Cheryl Bomdal, Fire Chief Gene Stevens, Michael Orman, and 1 guest at Canosia Town Hall. Mayor Werner, Clerk Toni Blomdahl, Councilor Herstad, Councilor Quade, Councilor Hegstrom, Councilor Heim, and Michael Couri were present from their town hall.

Chair Comnick called the meeting to order at 7:00 p.m., and the pledge of allegiance was recited.

NEW BUSINESS

A. ANNEXATION DISCUSSION: Supervisor Comnick introduced everyone present and Mayor Werner began his board meeting so that both entities were in session. Couri discussed the process for an Order of Annexation. He stated that there is a large development looking to build on a small portion of Canosia

Township. The City of Rice Lake will be providing the infrastructure for the development. The land is undeveloped, some of which is swamp. There are no residents or buildings on the parcels in question. He stated that in the agreement for annexation there will be a provision that Canosia Township will receive 50% of the property taxes of the parcels for 5 years once the development is built and tax abatement is over. He discussed the potential for appeals to the annexation and how that process would work. He discussed the importance of confidentiality. Mayor Werner stated that the discussion concerning the land began four years ago between the developer, Rice Lake, St. Louis County, and the City of Duluth. Canosia Township was not included in the discussions, even though the potential development would be occurring on township land. Mayor Werner reached out to Chairman Comnick in 2022 to discuss the project and engage Canosia Township in the discussions. Supervisor Comnick stated that he was disappointed that the township was not engaged earlier and was appreciative that the City of Rice Lake eventually notified them. He discussed his support of the annexation, in part, due to the desire to partner with the City of Rice Lake as they were the ones to inform the township of the potential annexation. Orman stated that the agreement is a good one for the township as it will allow and orderly annexation v. a forced annexation to occur and it allowed for new township revenue on land currently being unused. The board reviewed the maps related to the potential annexation, which include approximately 125 acres. Couri discussed how everyone would be notified and the publishing requirements for the annexation. Mayor Werner was clear during the meeting that the City of Rice Lake is not interested in annexing more of Canosia Township than the parcels being discussed at this meeting. They are simply interested in supporting the township in avoiding a forced annexation of the land by other entities. Board discussed further the process and timeline. Motion made by Kevin Comnick, seconded by Penny Dieryck to enter into a partial Orderly Annexation with the City of Rice Lake detailed in Resolution 2022-20. Motion carried unanimously. 3 - 0.
