Chair Dieryck called the meeting to order at 7:00 p.m., and the pledge of allegiance was recited.

- **D. ROADS:** Supervisor Comnick stated that gravel was added to two of the township roads and a donation enabled the cracks to be filled in and a seal coat completed in front of the fire department.
- **E. RECYCLE SHED:** Supervisor Dieryck stated that the garage door was covered due to direct sunlight. She also stated that she reminded the staff not to help people get items out of their vehicles. Asst Fire Chief Mortinsen asked her to have them stop collecting books.
- **F. RECREATION AREA:** Supervisor Dieryck stated that she received bids to level the ground under the play ground, swing quote, and bids for new fencing. She stated that Step One of the plan to fix the fencing around the little league field has been completed. She also ordered an additional portable bathroom. There is a meeting to discuss the recreation area long range plans on August 14, 2023 at 8:00am at the Canosia Township Town Hall.
- **G. CEMETERY:** Supervisor Dieryck stated that she saw a man at the cemetery and it looked like he was digging. Road Foreman Oswell stated that he would look into it.
- H. PLAWCS: Supervisor Comnick stated that explained the situation on South Pike Lake Road where there is line exposure on the property line adjoining two properties. He stated that the PLAWCS board intends on meeting on site to discuss the issue and determine an appropriate resolution. He also stated that there is a FEMA meeting on Tuesday to discuss next steps and to set up the applicants with portals. He stated that Supervisor Johnson (Grand Lake Township) and Donovan Frye (Duluth Accounting and Tax Service) will be present to help set up accounts for PLAWCS and the Town of Canosia. Supervisor Comnick also explained the MATIT Insurance currently purchased by PLAWCS and its limitations. He stated that the board will be discussing if the insurance levels need to be revised.
- I. AIS: Supervisor Comnick stated that they held an end of year pizza party for the inspectors. Wallace asked if there were inspectors at Caribou Lake. Supervisor Comnick stated that they were only at the Pike Lake public access through Labor Day. He also stated that next Tuesday the AIS Program will be reviewed, which is done annually.
- J. NOXIOUS WEEDS: Road Foreman stated that there are some weeds. L. Erikson asked if a roller could be rented to aerate the back fields. Supervisor Comnick stated that he would ask R. Anderson if they could use his.
