TOWNSHIP TAX LEVY & ANNUAL MEETING

The Canosia Town Board is once again recommending **NO INCREASE** to the township tax levy.

The Canosia levy has held steady at \$297,200 for well over a decade, meaning the township portion of your property taxes has held steady as well. The town board, in partnership with the Canosia Volunteer Fire Department, believes the recommended break down (on the right) will best serve the township's needs in 2022.

The General Fund includes the Parks & Recreation account which currently has a healthy balance due to a resident donation and funding from the past Proctor School District Referendum. Therefore, the board's recommendation reflects their proposed plan to budget no additional funds for Parks & Rec next year and instead use that \$10,000 to help fund upcoming road projects and continued maintenance.

The actual 2022 levy amounts will be determined by the residents attending the **Annual Meeting on Tuesday**,

March 9 at 8:30 p.m. Like most events of the past year, this one will be slightly different than usual due to the pandemic.

The meeting will be held in-person at the town hall (4896 Midway Rd.) and special care will be taken to ensure a safe, sanitized and socially-distant event. The agenda will also be streamlined for a faster meeting. For those who do not feel comfortable attending in-person, there will be an opportunity to participate remotely. Please bear with us as we navigate the logistics of conducting a meeting this way. We will have to conduct "roll call" voting where each participant (in-person and remote) states their vote, one at a time, on each necessary agenda item.

EARLY VOTING: If you can't make it to the polls on the 9th, you can vote absentee. The town hall will be open for absentee voting on Saturday, March 6 (10 a.m. to 12 p.m.) and Monday, March 8 (4 p.m. to 5 p.m.). In the case of severely inclement weather, the town board election, Board of Canvass and Annual Meeting will be rescheduled for Tuesday, March 16.

Town Board Supervisor KURT BROOKS opted not to run for re-election this year. Kurt served on the board for 6 years and made a huge impact. During his two terms, he has taken the lead on several projects including the modernization of our township cemetery records, the installation of the new town hall well and the creation of our long-term trail plan and new hiking/biking trail loop on Industrial Road. Kurt has also been instrumental in standardizing and organizing many of our township administrative/financial processes, resulting in greater transparency, effectiveness and value for our residents. Thank you, Kurt, for your kindness and leadership!

COVID RELIEF FUNDING

The Township received funds from the Coronavirus Aid, Relief and Economic Security (CARES) Act which enabled us to purchase Personal Protection Equipment (PPE) and make many upgrades to the town hall and fire hall to ensure the safety of our firefighters, employees and residents who visit the facility. In consultation with the Fire Chief and St. Louis County, we were able to acquire:

FIRE DEPARTMENT NEWS

211 TOTAL CALLS

In 2020, our volunteer fire fighters responded to

- 148 medical calls within Canosia
- 13 medical mutual aid calls
- 23 Canosia fire calls
- 26 mutual aid fire calls

211 is a record number of calls for our volunteers! Their commitment to helping their neighbors is greatly appreciated!

NEW FALSE ALARM ORDINANCE

Canosia Township will now be charging \$500 for repeated false alarm medical calls. This has been a growing problem in the township that zaps the time and energy of our volunteer firefighters and misuses the township resources. The \$500 service charge will be applied after the second false alarm medical call made within 6 months. If not paid, the charge will be assessed to their property taxes.

EMERGENCY ALERTS

You can now sign up to receive local emergency notifications such as police activity in your area, severe weather, unexpected road closures, missing persons, community news and evacuations of buildings or neighborhoods. To subscribe visit:

You can choose what types of alerts you wish to receive and from what participating agencies in St. Louis County, Duluth, Hermantown, Hibbing and Virginia. You can also choose how to receive the alerts (text, email, or automated phone call).



RECYCLING PLASTIC BAGS & FILM

Plastic bags can be recycled – but NOT with your other recyclables. At the township recycling site, look for our orange barrels to deposit your plastic bags.

Please, please do not put them in the big recycling bins with the rest of your items! Bags can clog the sorting equipment and invalidate the efforts of all our recyclers. Plastic bags and film must be <u>clean and dry</u>. Remove any receipts or other items from bags. To tell if plastic bags or film is recyclable, you should be able to stretch the plastic when press-ing a thumb into it. Common acceptable and unacceptable items are listed below.



- ⊕ Retail, grocery or carry-out bags
- \oplus Produce bags, fresh and frozen
- \oplus Air pillows for shipping (deflate
- ⊕ Food storage bags
- ⊕ Newspaper sleeves
- ⊕ Dry cleaning/garment bags
- Wrap from products like
 - Cases of pop or water
 - Toilet paper, disposable diapers, sanitary products
 - Napkins, paper towels, disposable cups
 - Furniture, mattresses, electronics



- ⊗ Black plastic garbage bags
- \otimes Dirty or wet plastic film
- ⊗ Woven plastic bags
- Bags or plastic film with a lot of sticky paper labels that won't come off.
- \otimes Just throw these items in the trash.

HISTORICAL SOCIETY

The Canosia Township Historical Society has submitted the following article as a reminder of how much can change in 101 years. The content was originally published in the Duluth News Tribune in 1920.

DULUTH WOMAN NAMED CARRIER; FIRST IN STATE

Mrs. Mary Sarff Receives Notice of Appointment to Rural Mail Route

Mrs. Mary L. Sarff, 9p7 Fourth avenue East, yesterday received from Washington, D.C., her formal appointment as a rural mail carrier at a salary of \$1,800 a year. She is the first woman to pass the examination in the state of Minnesota, Col. W. F. Henry, acting postmasters, says, and is one of only a half dozen women rural carriers in the United States. Mrs. Sarff is married and has two children. Her husband is employed in Duluth.

She has already demonstrated her ability to carry Uncle Sam's mail, as she has covered the 27 miles included in route No. 1, on the Pike Lake road, for more than a year while acting as a substitute.

Likes the Work.

"I am glad to know that I passed the examination all right," Mrs. Sarff said yesterday as she busied herself sorting and tying the bundles which she will distribute along her route today. "I like the work fine. Even in muddy weather, when it is sometimes doubtful whether a 'flivver' is going to remain in the road or take to the ditch, I enjoy the job just the same."

During the winter months, when the deep snows make it impossible to cover the route with a car, Mrs. Sarff uses a horse and buggy. She has never missed a day, Colonel Henry says, although there have been days during heavy snowstorms, when the roads were considered impassable.

Women Are Efficient.

"Mrs. Sarff is probably the last woman who will be appointed in this district," Col. Henry said. "Since the war the shortage of men has not been felt so keenly and a great number of ex-soldiers, who must receive first consideration, have taken the examinations for positions in the postal department. "Our experience with women who have entered the department during the war period has demonstrated that they can be fully as efficient as the men."
